CONSTRUCTION v. COVID-19 LEGAL UPDATE >

EFFECTIVE IMMEDIATELY: NEW CAL/OSHA COVID-19 EMERGENCY STANDARDS Chad T. Wishchuk

On November 30, 2020, the California Department of Industrial Relations' (DIR) Occupational Safety and Health Standards Board adopted a Cal/OSHA emergency temporary standard regarding COVID-19. The emergency temporary standard went into effect immediately and affects most California companies. It brings with it new documentation, COVID-19 testing, reporting, and other obligations.

WHO IS COVERED?

The new standards apply to all California employers, employees, and places of employment except:

- Employees in healthcare and laboratory settings covered by the existing aerosol transmissible diseases standard
- Workplaces with only one employee who does not have contact with other people
- Employees who are working from home

WHAT IS REQUIRED?

California employers must develop a written COVID-19 Prevention Program or ensure its elements are included in an existing Injury and Illness Prevention Program, and implement the following in accordance with their written program:

- Identify, evaluate, and correct COVID-19 hazards
- Physical distancing of at least six feet unless it is not possible
- Provide and ensure the use of face coverings

- Procedures to investigate and respond to COVID-19 cases in the workplace
- Provide testing to employees who are exposed to a major outbreak in the workplace
- Exclusion of COVID-19 cases and exposed employees from the workplace with pay until they are no longer an infection risk
- Maintain records of COVID-19 cases and report to Cal/OSHA and the local health departments, as required

Also included are training requirements on how COVID-19 is spread, infection prevention techniques, and information regarding COVID-19related benefits that affected employees may be entitled to under federal, state, or local laws.
